## PAR's 2006 Annual Conference Focuses on Recovery

PAR's 2006 Annual Conference and Luncheon created an opportunity for state leaders and decision makers to discuss hurricane recovery and preview plans for rebuilding. This year's conference, held at the Holiday Inn-Select in Baton Rouge on April 5, focused on practical solutions to recovery and governmental oversight in rebuilding. The event was co-chaired by **Donna Carville** of Plaquemine, Public Affairs Manager of Dow Chemical Company and **George H. Wilson, Jr.** of New Orleans, President/CEO of Barriere Construction Co., L.L.C.

PAR Board Chairman **Dr. James Peltier** introduced the luncheon featuring **John Maginnis**, syndicated political columnist and publisher of *Louisiana Political Fax Weekly*, and keynote speaker **Susan Roesgen**, Gulf Coast Correspondent for CNN News.

In her keynote address, Roesgen discussed media coverage of Hurricane Katrina and the recovery efforts. She reminded the packed crowd of elected officials and business leaders that Louisiana must rise to the occasion to rebuild better and called for accountability and transparency throughout the recovery process.

The morning panel session, entitled "Louisiana's Options in Housing – State and Local Perspectives," was moderated by **Robyn Ekings** of Louisiana Public Broadcasting and featured Executive Director of the Louisiana Recovery Authority **Andy Kopplin**, Chairman of the New Orleans Business Council & CEO of Laitram Corp. **Jay Lapeyre**, **Mayor Randy Roach** of Lake Charles and **Representative Jim Tucker** of Jefferson and Orleans Parishes. The panel discussed the housing plans from the Louisiana Recovery Authority, the need for transparency in spending, connecting the government with private contractors, the timetable for rebuilding and plans to house evacuees in more permanent residences.

**Louis Freeman**, recipient of *The Times-Picayune* Loving Cup. The Loving Cup has been awarded since 1901 to men and women who have worked unselfishly for the community without expectation of public recognition or material award. Freeman was chosen for this prestigious award in recognition of four decades of work with a broad array of organizations and causes.

**Mel Lagarde**, co-chair of the Bring New Orleans Back Commission. In this role, Legarde has served as a representative of the New Orleans rebuilding process to the national government and local citizens. His extraordinary efforts are helping to create a master plan to rebuild New Orleans culturally, socially and economically.

**Ashton Phelps**, for the two Pulitzer Prizes won by *The Times-Picayune*. The gold medal for meritorious public service was awarded for the newspaper's "heroic, multifaceted coverage of Hurricane Katrina and its aftermath, making exceptional use of the newspaper's resources to serve an inundated city even after evacuation of the newspaper plant". *The Times-Picayune's* Pulitzer price for distinguished reporting of breaking news recognized "courageous and aggressive coverage of Hurricane Katrina, overcoming desperate conditions facing the city and the newspaper."

**Sean Reilly**, member of the Louisiana Recovery Authority. Reilly is a leader on the Louisiana Recovery Authority and serves as chair of its State and Local Legislative Task Force. He is working tirelessly to plan for Louisiana's future, coordinate across jurisdictions, support community recovery and resurgence and ensure integrity and effectiveness.

## Grants Enhance PAR's Work

## PAR Research

### Recently Released Reports

***Hurricanes and Health Care Reform: Can Louisiana turn a disaster into an opportunity?*** This is the first report in an ongoing series of PAR health care policy briefs highlighting major issues that impact health programs and state and federal spending in Louisiana. This report provides an overview of the state's health system and its deficiencies, as well as the challenges and opportunities presented by hurricanes Katrina and Rita. The overview shows that Louisiana has a broken and dysfunctional health care structure, which is poised for major reforms. Spending and performance data are compared to other states to show that Louisiana is a high-spending state with the worst health care outcomes in the country.

***Municipal Bankruptcy in Perspective*** A study conducted jointly with the Bureau of Governmental Research (BGR) in New Orleans examined municipal bankruptcy as an option for local governmental entities in the 31-parish disaster area. The study examined the advantages and disadvantages of municipal bankruptcy with a special focus on the City of New Orleans and the Orleans Parish School Board.

***Education Finance Reform: A 65% Solution?*** PAR published an analysis of a proposal to require that at least 65% of school district expenditures goes to classroom instruction. Supporters of the 65% Solution argue it would increase the amount of money spent in the classroom without raising taxes and would reduce wasteful costs. But, PAR's analysis of spending and performance data concludes that the proposed 65% instructional spending requirement would reduce the flexibility of state-provided education funding without any assurance that student performance would be improved.
