Obtain Copies of Legislative Documents

Citizens may obtain copies of House and Senate bills (original or as amended), daily House and Senate journals, status of bills, and the order of the day from the Senate Bill Room outside the Senate committee hall in the basement of the capitol.

Copies of legislative bills and other documents may be ordered by phone through the PULS line.

The Legislature charges for legislative documents at 10 cents a page, or a fixed price for sets of documents for the entire regular session.
