The Public Affairs Research Council of Louisiana (PAR) is seeking a Director of Development to lead fundraising programs for the nonprofit, non-partisan educational public policy organization. The Director of Development will be a vital part of PAR's leadership team who can take the organization to its next stage of development, fulfill its strategic plan and excel at pursuing PAR's mission.

RESPONSIBILITIES

General fundraising duties

- Help our members and donors accomplish their philanthropic goals through a relationship with our organization
- Assume the primary role for PAR's fund development activities including prospect identification, grant writing, special events, and membership retention and acquisition strategies
- Organize and manage corporate sponsorships, major gifts, special projects and membership appeals
- Identify and connect funders to PAR's programs, initiatives, products, services and research, and education projects, as appropriate
- Write and edit grant and major gift proposals, correspondence and solicitations, and assist with creating development collateral
- Manage intentional relationship-building activities from engagement to stewardship in preparation for endowment growth and a future capital campaign
- Manage systems and software to track and cultivate donors and prospects, including our CRM

Special Events

- Take the lead role in fundraising for PAR's annual conference and luncheon, including presenting and table sponsors
- Research potential new sponsors and maintain updated prospects in database
- Develop and raise funds for new PAR events

Grant development

- Cultivate private grant opportunities among state and national foundations and corporations
- Maintain strong contacts with grant makers

 Track and meet grant and donor timelines and requirements for full compliance with deadlines and reporting

Relationships

- Establish ongoing relationships with major donors
- Collaborate on major gift strategies with the PAR President and Board of Directors
- Develop and maintain major gift portfolios
- Work with the Membership & Development Committee of the Board of Directors to develop strategies to initiate and meet fundraising goals
- Assist the Board with maintaining major donors and soliciting new donors and members
- Seek opportunities and provide guidance to improve and publicize PAR's image
